a) Motion 28.09.2012 – 01: Motion to reaffirm support for reinstatement of Post-Residency Fees

Moved by: Elizabeth Whyte (VP Finance)
Seconded by: Chloë Grace Fogarty-Bourget (VP Operations)

Whereas in 1996, the Board of Governors eliminated post-residency fees for graduate students at Carleton University; and

Whereas a post-residency fee structure allows graduate students to pay reduced tuition fees following the completion of their course work, a practice that recognised the reduced resources used by students in the research and writing phases of their degrees,

Whereas post-residency fees reduce the financial barriers faced by students pursuing a graduate education

Whereas the elimination of post-residency fees has served to reduce completion rates as graduate students seek paid employment and even drop out of their studies in order to survive; and

Whereas tuition fees as a barrier have a greater impact on international students, students with disabilities, single parents, women, Aboriginal students, and students from low and modest income backgrounds; and

Whereas in certain Carleton University programs, such as Social Work, requiring payment of full tuition fees is further exacerbated by the practise of charging these fees to students who are engaged in practicum – amounting to students having to pay fees in order to work; and

Whereas in 2007 the Carleton Graduate Students' Association endorsed the campaign to reinstate post-residency fees; and

Whereas re-instating post-residency fees would:

- help to open the doors of graduate studies to qualified students from all backgrounds and income groups and demonstrate that Carleton University is committed to accessible graduate education;
- increase retention rates and reduce time-to-completion rates, thereby increasing the research and teaching capacity of Carleton University; and

Be It Resolved That the Carleton Graduate Students' Association reaffirm its support for the Ontario Graduate Caucus of the Canadian Federation of Students-Ontario (OGC) campaign for a restoration of post-residency fees; and

b) Motion 28.09.2012 – 02: Motion to respond to Ministry of Training Colleges and Universities Discussion Paper

Whereas Ontario has the highest tuition fees in Canada at both the graduate and undergraduate levels; and

Whereas Ontario has the lowest per-student funding in Canada; and

Whereas the Ministry of Training Colleges and Universities (MTCU) document *Strengthening Ontario's Centres of Creativity, Innovation, and Knowledge* seeks to radically transform post-secondary education; and

Whereas *Strengthening* does not mention or address the issues of financial access, student debt, or overall affordability of education; and

Whereas Strengthening suggests importing aspects of the European Bologna Process, including 3 year degrees and year-round classes, a process that has received widespread criticism and has had little benefit to students; and

Whereas *Strengthening* suggests linking calculations of "learning outcomes" of students to the funding of universities and colleges; and

Whereas the GSA recently held a townhall to solicit feedback from students on the future of postsecondary education in Ontario; and

Whereas this summer members of the GSA executive participated in the *Innovation Productivity Roundtable Discussions* where members of the post-secondary sector were invited to discuss the *Strengthening* document; and

Whereas the Graduate Academic Caucus recently met to discuss Strengthening and provide feedback,

Be it resolved that the Graduate Students' Association submit feedback on the *Strengthening Ontario's Centres of Creativity, Innovation, and Knowledge* document to the Ministry of Training Colleges and Universities; and

BIFRT the Graduate Academic Caucus and the GSA Executive continue to monitor proposed changes to the post-secondary education system in Ontario; and
