6. EXECUTIVE REPORTS

Sexual Violence Policy

For those unaware, every student has received an email from Carleton administration regarding the latest draft of the sexual violence policy.

The purpose of this email is to continue the consultation process with the entire Carleton population. As you know, prior to this the consultation process involved selected students' groups like service centres, the GSA, labour unions, etc.

We strongly encourage that all of you provide your feedback and relay this encouragement to your departments as well.

You can provide feedback through the online form or by email before October 28th.

The GSA is waiting to meet with our campus and labour union allies before we release a public statement.

Carleton Academic Student Government (CASG)

This past Wednesday, I represented the GSA at the first CASG meeting of the school year. The Carleton Academic Student Government, CASG, is the official body representing undergraduate students at Carleton on academic issues. The councillors represent the student voice on important issues such as changes to courses (including adding, modifying, or deleting the courses), changing requirements for a certain degree, and even have the power to discuss and vote on creating or ending an entire degree program.

At this meeting there was a motion to vote Chloe Miller, the interim CASG president, to the official president role after the previously elected president stepped down in the summer. The motion was successful.

The meeting proved to be useful to help promote the November 2^{nd} National Day of Action to a group of active undergraduate students.

Athletics Board

The first athletics board meeting was this week. All four student representatives were present: GSA, CUSA, RRRA, and the Varsity Council Rep.

After much discussion, we have crafted seven priority areas for the implementation of the TRC report at Carleton, and building on the many valuable initiatives already in place on campus. These seven areas have been presented to the AEC and will be detailed with concrete recommendations at coming meetings:

Creating a Respectful and Inclusive Learning Environment: Articulating a Vision for Carleton University based on the TRC's Calls to Action

- 1. Increase awareness of Indigenous cultures, knowledges and history
- 2. Prioritize teaching and revitalization of Indigenous languages with a preliminary focus on Anishinaabemowin, Mohawk, Michif and Inuktitut
- 3. Include Indigenous worldviews, ways of knowing and teaching methods in the classroom
- 4. Enhance community partnerships and establish relationships with Indigenous communities and organizations
- 5. Focus on Indigenous learner success
- 6. Remove systemic barriers and improve access to Indigenous education
- 7. Increase support for Indigenous research

8. DEPARTMENTAL REPORTS

Danielle Taylor: English, raise an issue, that's with the process of obtaining external funding, number of our students go through difficult process of getting that fund and getting information about obtaining it. Including misinformation when phoning, told one thing and another thing next. We just had a couple of students who wanted that to be raised, still an issue. One student who has been out of university and this isn't a typical process, more streamlined usually. This is an issue for students, trouble and stress in trying to gain this funding. Finances don't want to be stressed out about.

Michael Bueckhart: mention briefly from Soc/Anthro, will be discussed later, concerns for students going into 6th year with school trying to force them to finish degree faster, difficulty to even register, forced to pay extra high fees which wasn't a thing before even trying to intervene and go around supervisor and dictate deadlines for completing a chapter, that kind of thing. The administration to supersede the academic supervisor to determine terms of research. Not sure if other departments are seeing this but it's something we're investigating and talk about more.

William Felepchuk: one of the main things bringing up with FGPA, issue of completion dates, inconsistent, based on how much money they get per domestic student, runs about after a certain amount of years with international students they don't have this because they don't get money from the government, just collect the cash which is much higher than our tuition and in some programs encourage them to stay longer. So one part of student body treated one way and the other another way.

Phil Robinson: respond to Danielle, Will and/or I will email you to get more information particularly about who was giving wrong information to the students and who was doing that. Meeting with dean of grad studies on Tuesday, issue of this scholarships is at the top of our agenda, will be helpful to get that feedback.

Whereas many GSA members are student parents and guardians caring for children while pursuing their studies; and

Whereas student parent and guardian members face numerous financial and time barriers to successfully completing their degrees; and

Whereas these barriers include the often overwhelming costs of childcare; and

Whereas access to childcare is difficult to obtain and expensive outside of regular daycare and school hours:

Whereas many extracurricular academic activities such conferences and speaking events, important to a successful career in academia, take place on evenings and weekends;

Be it resolved that the GSA adopt the following policy:

Childcare Grant (Student-Parent or Guardian Participation in Extracurricular Academic Activities)

Preamble

The purpose of the Childcare Grant (Student-Parent or Guardian Participation in Extracurricular Academic Activities) is to help graduate student parents and guardians pursue academic related events outside of regular childcare hours. The grant defrays the costs of childcare for parents attending academic events

The Grant

- 1. The GSA shall award a maximum of \$250 per applicant per GSA fiscal year (01 May to 30 April) to offset the costs of childcare.
- 2. Applicants are entitled to apply for more than one grant per fiscal year (01 May to 30 April), where the total of all grants awarded to any one candidate will not exceed the maximum award per applicant in one fiscal year (\$250.00).
- 3. The grant shall not be awarded to provide childcare during regular childcare hours or the child's regular school hours.
- 4. The grant shall not be used to provide childcare for ongoing seminars, classes, or courses that are part of the student parent's or guardian's degree (occasional activities only).
- 5. No childcare covered by a GSA Travel Grant may be used in an application for this grant.
- 6. The grant shall not be awarded for childcare that may be covered in the collective agreement between CUPE 4600 and Carleton University.
- 7. The GSA reserves the right to refuse any application, and retains sole discretion to determine approved funding amounts.
- 8. Grants will cease to be awarded when the budgeted maximum for these grants has been dispersed.
- 9. Grants shall operate on a reimbursement basis after the childcare has been provided.

Applications for Reimbursements

- 1. Applications may occur in advance in order to obtain approval for the grant.
- 2. Applications must be approved by the Vice-President Finance or designate, and will normally be processed within five (5) working days of application date providing that all the criteria have been met.
- 3. Grant application forms will include a brief description of the event and a brief justification for the event's relevance to the applicant's academic life, a copy of the applicant's ID, and a copy of the ID for each child like a provincial health card or birth certificate.
- 4. Receipts for the childcare must be submitted for the reimbursement to occur.

5. The deadline for applications is April 15 of the GSA fiscal year in which the childcare has occurred.

Appeals

- 1. Applicants may appeal a decision regarding their grant to the GSA Carleton Inc. Board of Directors.
- 2. By a majority vote, the GSA Board of Directors will decide any appeal of a grant decision.
- 3. All appellant decisions of the GSA Carleton Inc. Board of Directors are final.

BE IT FURTHER RESOLVED that the GSA create a new budget line, entitled "Childcare Grant: Student-Parent Participation in Extracurricular Academic Activities," and that it be funded by \$4,000.00 annually.

Motion passes unanimously

Michael Bueckhart: in meeting next, talking about financial audit, not sure that some of our friends from CUSA and CUPE can participate but extend invitation to be part of the discussion. Can't make a motion, needs to be at corporate meeting, want people to know that I'm going to put forth a motion.

Jessica Squires: do people know what we're talking about?

Phil Robinson: wanted to clarify, for the corporation, the language states that graduate student voting members are part of the corporation, Michael is suggesting we could extend attendance to grad faculty board and CUPE, CUSA, if anyone else who isn't a graduate student body that can be included that could be the first item on the corporate meeting. This council can't dictate this, would need to start meeting and then make the change.
