We are not innocent in the ongoing colonization of these lands and we resolve to challenge the presence of colonialism in our words, actions, and communities. We extend our ongoing solidarity to the Algonquin nation with our words, actions, time, skills, and resources.

Donor funded awards update – there have been several issues with respect to these awards, and the awards office was not particularly helpful in answering some questions. I have challenged them on the deadlines, the selection process, the ease with which students can access information on awards etc. They have promised to work on this but unless we keep pushing them on this, we may never get answers. My hope is to continue to seek answers from them on this.

#### **Mental Health**

The Political Action Committee (PAC) has officially launched the petition for better grad mental health care on campus. On February 15, the Charlatan covered the launch of our petition and Debbie was interviewed. We have collected over 300 signatures so far and encourage councillors to share the petition in their department. We also received our first batch of anonymous testimonials about mental health services and they have been put up on our Instagram and Facebook.

This month, the call went out to councillors asking if anyone wanted to help represent grad students in the "Grad Student Mental Health Working Group" being spearheaded by Matthias Neufang and Paul Keen. There are 5 reps on the committee so far (Hemant Gupta, Timothy Whalen, Laura Dunbar, Jenna Amirault, and Zidan Mohamed).

"Climate Change. Pipelines. War. Racism. How can we take nonviolent direct action to confront and transform injustices? What is and how does one organize a sit-in, a blockade? What happens if I get arrested? How can we be effective, accessible, transformative, and creative in our nonviolent direct actions? How do we care for one another in an action/campaign? This workshop on nonviolent direct action and creative protest will involve discussions on the history and philosophy of nonviolence, practical applications of this theory through civil disobedience/civil resistance, role plays, explorations of tactics to de-escalate crises, the legal ramifications of and winning courtroom strategies for civil disobedience (arrests, courts, detention), the role of affinity groups, self- and community-care as foundational principles for political action, accompaniment and witness as forms of solidarity, and more. This workshop is organized by Homes not Bombs, whose facilitators have conducted hundreds of such workshops throughout Ontario in jails, schools, labour unions, church groups, university campuses, and in preparation for major gatherings such as WTO meetings and G7 summits. Homes not Bombs is organizing with the Ontario-Muskrat Solidarity Coalition a nonviolent direct action on May 7 on Parliament Hill in solidarity with the Labrador Land Protectors"

## Day of Action - February 1st

The GSA, OPIRG, and the Canadian Federation of Students held a successful Day of Action at which the campaign to address mental health services was launched. Student issues were highlighted and discussed, which is especially pertinent given the upcoming provincial election.

#### **Justice for Soli**

The GSA collaborated with the Muslim Student Association and the Student Federation of the University of Ottawa on the Justice for Soli Campaign. The GSA rented a bus to transport students from Carleton to an event at the University of Ottawa. The campaign is being led by a family who lost one of their members while being detained in prison and suffering from serious mental health issues. A motion on the campaign is being presented at this meeting.

## Solidarity with CUPE 2424

GSA Council passed a motion expressing solidarity with CUPE 2424 at its November 2017 meeting. The GSA and CUPE 4600 will be hosting an information session at 2:30 pm on Thursday, March 1, in the Grad Lounge (6<sup>th</sup> floor University Centre). A representative from CUPE 4600 will give an overview of the main issues in bargaining and will take questions. Free pizza will be served. I encourage Councilors to let their colleagues know about this event.

CUPE 2424 will also be holding a rally in the Atrium at noon on March 2. Everyone is invited and encouraged to wear blue.

In the event of a strike or lockout, the Union has not requested that the GSA offices relocate off campus or that Mike's Place close in solidarity. Rather, we are hoping that these locations can be spaces for students to discuss ongoing labour relations issues at Carleton University.

## a. Motion 27.02.2018 - 01: Justice for Soli Motion

Moved By: Jenna Amirault (VP-External)

Seconded By: Abigail (Sociology)

Whereas on December 4, 2016, Solieman Faqiri was temporarily housed at the Central East Correctional Centre (CECC) in Lindsay, Ontario while awaiting a bed at the Ontario Shores Centres for Mental Health; and

Whereas Solieman had been previously diagnosed with schizophrenia and was identified as having urgent mental-health needs by his family and correctional staff; and

Whereas On December 15th 2016, only eleven days after being temporarily housed at CECC, Solieman was killed by guards after they applied force on him; and

Whereas the Coroner's report shows that Solieman had sustained 50 injuries on his body. A significant number of these injuries were due to blunt impact trauma following a prolonged altercation with prison guards in the segregation cell; and

Whereas despite the extensive findings of the Coroner's report, the City of Kawartha Lakes Police Service ruled that "no grounds exist to process criminal charges against anyone who was involved with Mr. Faqiri prior to his death", according to inspector Will Herbert; leaving the cause of Soleiman's death unknown and with no accountability for it; and

Whereas Soleiman was not the first or last individual with mental health disabilities to die in an Ontario prison. The Ontario Human Rights Commission recently launched a legal action against the government of Ontario over its illegal use of solitary confinement detainment for prisoners with mental-health disabilities, in violation of a legally binding 2013 agreement signed by the province around the treatment of Christina Jahn; and

Whereas The Faqiri family remains concerned with the lack of transparency and accountability expressed by the Kawartha Lakes Police Service; and

Whereas On November 3, 2017 the Ontario Regional Coroner announced an inquest to publicly examine the events surrounding Solieman's death; therefore

Be it resolved that the GSA donate \$500 to for the Faqiri family's legal representation at the upcoming inquest.

# b. Motion 27.02.2018 - 02: Motion to Approve a CUSERT Referendum Question in the GSA General Elections

Whereas the Carleton University Student Emergency Response Team (CUSERT), provides 24/7 emergency medical response services on campus, and;

Whereas CUSERT responds to all members of the Carleton community, regardless of whether they are undergraduate students, graduate students, staff/faculty, or visitors to campus, and;

Whereas CUSERT has a proven track record of improving emergency response on campus and supporting emergency services in Ottawa, and;

Whereas CUSERT has a wide range of operating costs, ranging from supplies/equipment to training, and;

Whereas CUSERT is completely funded by student levies, despite working under the Department of University Safety, and;

Whereas the GSA has never had a levy set to help cover the costs of CUSERT, and;

Whereas CUSERT is constantly working to improve its response by seeking out new training and equipment, and is currently increasing its scope of practice, and;

Whereas CUSERT is a volunteer service that that both undergraduate and graduate students can apply to; therefore

BIRT the following referendum question be asked in the 2018 GSA General Elections:

Do you support creating a levy of \$1.31 per semester, indexed to the Consumer Price Index and prorated for part time students, to support the Carleton University Student Emergency Response Team (CUSERT)? Yes/No

## c. Motion 27.02.2018 – 03: Justice for Indigenous People

Moved By: Jay Ramasubramanyam (VP-Academic) Seconded By: Helyeh Doutaghi (Legal Studies)

Whereas, in the last couple of weeks, we have seen court decisions contrary to indigenous justice on two specific cases; and

Whereas, on August 9, 2016, an Indigenous man, Colten Boushie, was shot dead by Gerald Stanley in Battleford, Saskatchewan, and on August 17, 2014, an Indigenous woman Tina Fontaine was found murdered in Red River, Manitoba, by Raymond Cormier; and

Whereas at Stanley's and Cormier's trials in February 2018, an all-white jury in both cases acquitted them of wrongdoing resulting in no accountability for Boushie's and Fontaine's deaths; and

Whereas the Boushie and Fontaine families continue to fight against the injustice meted out to them and other Indigenous peoples across Canada, and the apathy of the judicial system; therefore

Be it resolved that the GSA, with the support of the Council, write a letter to the Attorney General of Canada, The Honourable Jody Wilson-Raybould, urging an inquiry into each of the trials.
